Biographical data:

After graduating from high school in Lovech at the Language High School with German and English teaching Exarch Joseph, he continued and graduated from the Medical University of Sofia with a degree in Medicine in 2004. As an officer from the Military Medical Academy, the candidate began specialization in Internal Medicine at the Military Medical Academy - Sofia with the acquisition of a specialty in 2009, then acquired a specialty in Gastroenterology in 2012. Since 2011 holds the position of resident physician, Department of Gastroenterology; Clinic of Gastroenterology and Pulmonology at Tokuda Hospital Sofia and since 2015 so far - Head of the Department of Interventional Gastroenterology, Clinic of Gastroenterology and Pulmonology; Acibadem City Clinic UMHAT Tokuda, as of 2020. is Chief Assistant.

Research activity:

The candidate presents a total of 83 scientific papers, of which 31 are real publications in Bulgarian, 12 - in foreign journals, 2 co-authorship in monographs and textbooks. 19 abstracts of congresses published in journals with impact factor and 20 - in collections and non-peer-reviewed journals were presented. The detailed list of publications is presented in tabular form with the required specifics.

The number of publications fully satisfies and significantly exceeds the scienstometric criteria for holding the academic position of "Associate Professor" (1223/400 points). A total of 35 citations were found from the report presented by the CMB. The total impact factor of the candidate is 26,087.

The scientific works of the candidate are in the following main directions:

- Digital oral cholangiopancreatoscopy (DPOHPS) in the diagnosis and treatment of - Echoendoscopic biliary drainage
- Echoendoscopic pancreatic gastrostomy
- Mini-invasive approach in the treatment of late recognized esophageal perforations - latrogenic perforations of the colon and duodenum

- Liver biopsy under echoendoscopic control
- latrogenic lesions of the bile ducts
- Echoendoscopic-navigated fine-needle biopsies
- Oral techniques for diverticulostomy
- Biliary intervention procedures in pediatric practice - Percutaneous endoscopic gastrostomy with jejunal extension in patients with Parkinson's disease

Contributions of clinically applied and didactic nature:

- Clinical behavior and treatment of Gastroesophageal Reflux Disease, Barrett's Esophagus, Pancreatic Carcinoma, Chronic Pancreatitis, Cystic Pancreatic Neoplasms, Diverticulosis of the Colon, Functional Dyspepsia, Chronic Inflammatory
- Recommendations, possibilities and practical guidelines in the interventional Bowel Disease and Ulcer. treatment of bile duct stones, endoscopic stenting in malignant biliary obstructions, interventional procedures under echoendoscopic control. Recommendations for endoscopy and organization of work in the endoscopic sector in the conditions of
- Treatment of some rare diseases and conditions, such as radiation esophagitis, precancerous lesions of the bile ducts, some rare duodenal diverticula, abdominal ossification after polytrauma, drug damage to the bile ducts, IMPN, biliary complications after liver transplantation.
- Trends, current scientific achievements and current recommendations for behavior in cystic pancreatic lesions, malignant colon polyps, Barrett's esophagus, esophageal
- Co-author of a monograph on "Chronic pancreatitis", presenting the place and role of endoscopic techniques in diagnosis and therapy, technical guidelines for their implementation, specific forms and complications of chronic pancreatitis. Co-author in the guide "Behavior in pancreatic ductal adenocarcinoma" (SEA 2021) - defining guidelines for the use of endoscopic ultrasound in the diagnosis and staging of pancreatic ductal adenocarcinoma and mini-invasive endoscopic techniques for control of biliary and duodenal obstructive situations.
- Co-authorship in the manual "Behavior in pancreatic ductal adenocarcinoma" (SEA) 2021) - defining guidelines for the use of endoscopic ultrasound in the diagnosis and staging of pancreatic ductal adenocarcinoma and mini-invasive endoscopic techniques for control of biliary and duodenal obstructive situations.

Dr. Karagiozov is a long-term lecturer, and in the report on his activities from Sofia University and ASK UMHAT Tokuda certifies 1111 hours for Tokuda Hospital with specialists and 600 hours, of which 15 - classroom employment at Sofia University.
