Proffessional development:

Dr. Valeri Liubenov Gelev graduated from high school in 1982 at the English Language School, Sofia. He completed his higher medical education in 1990 at the Medical University - Sofia. In 1995 he acquired the specialty of Internal Medicine, and in 2000 - Cardiology. In 2003 he received a certificate in invasive cardiology. He has been working successively in the Department of Invasive Cardiology at the National Heart Hospital, Head of the Department of Invasive Cardiology at the Institute "Pirogov", and since 2013 he has been Deputy Head of Cardiology Clinic at Acibadem City Clinic Tokuda Hospital. In 2016 he completed a master's degree in health management at the Faculty of Health Sciences MU-Sofia. Dr. Gelev attends a number of international courses in interventional cardiology and is a member of the Board of the Bulgarian Society of Cardiology (2020-2022), member of the Board and President of Bulgarian Society of Interventional Cardiology (2009 – 2019), member of European Society of Cardiology and etc.

Scientific and research activity:

In this procedure Dr. Gelev presents a total number of 90 scientific titles including his dissertation, 72 original publications and 17 scientific presentations. From them 68 are scientific papers – 32 published in Bulgarian and 36 in international journals. There are two co-authorships in peer-reviewed monographs with an ISBN and one co-authorship in a textbook. There are substantial number of citations – 3749 and impressive impact factor of the publications.

Dr. Gelev's research interests are primarily related to his long-term daily diagnostic and treatment activities in the field of interventional cardiology and are focused on chronic coronary occlusions including the topic of his dissertation, transradial approach, percutaneous interventions for the treatment of left main disease and other complex interventions and etc. The scientific production of the candidate in this procedure is with original character and with a

Educational activity

Dr. Gelev is a completed and recognized at a National professional level expert, with pedagogic skills in the field, well known and highly respected educator, lector, teacher, moderator and consultant. He has vast language culture that helps him to be up-to-date with scientific literature and to actively participate and be recognized in international scientific forums.
